- Conduct championship level competition for its membership constituency (men, women & youth) and comply with state and local laws in the area
- Discharge their duties, as members of the Board and of any Board Committees on which they serve, in accordance with their good faith judgment and in the best interest of the members and the sport
- Become and remain familiar with the Association and the services the Association provides to the membership
- Commit the time necessary to prepare for, attend and actively participate in regular and special meetings and activities of the board and of the Board committees on which they serve
- Inform the President of the Board of changes in their employment, other board positions, events, circumstances or conditions that may interfere with their ability to perform the Board or Board Committee duties
- Adhere to the attendance policies that are in place for the Board
- Maintain the confidentiality of all material non-public information about Board activities, its business and affairs and make no use of it other than for furtherance of the Board's interests.
- Participate in the Registered Volunteer Program and follow all of the procedures, rules and policies that constitute the program.

### **Candidate Eligibility:**

A candidate for the board must be:

- A USBC member in good standing of the association at the time of election and throughout their term
- Elected or appointed without regard to race, color, religion, gender, disability, national origin, or age, other than the minimum age of 14, unless state laws mandate a specific age, and be reasonably representative of the membership
- A candidate for election or appointment as a Director of the GMUSBC Association must have attended at least one annual meeting within a two-year period immediately preceding nomination.
